PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to construct AN UNNAMED RESERVOIR and store waters from UNNAMED STREAMS 1 AND 2, TRIBUTARIES OF KENTUCK SLOUGH, to be appropriated under Application 69229, Permit 50731 for DOMESTIC USE FOR THREE FAMILIES to include irrigation of not to exceed one-half acre lawn and noncommercial garden for each family. The permit to store these waters is granted under Reservoir Application R-69228 with a date of priority of AUGUST 11, 1987. The amount of water entitled to be stored each year under such right, for the purposes aforesaid, shall not exceed 2.64 ACRE-FEET, BEING 1.32 ACRE-FEET FROM STREAM 1, AND 1.32 ACRE-FEET FROM STREAM 2.

The dam will be located in the:

SE 1/4 SE 1/4, Section 1, T 25 S, R 13 W, WM;

The maximum height will be 9.9 feet above the stream bed or ground surface at the centerline. The top width will be 14.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.0 feet. The area submerged by the reservoir, when full, will be 0.83 acre and the maximum depth of water will be 8.0 feet.

The area submerged by the reservoir is located in:

1/4 1/4	SECTION	TOWNSHIP	RANGE, WM
SE SE	1	25 S	13 W

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Actual construction work shall begin on or before SEPTEMBER 26, 1990, and shall be completed on or before October 1, 1991. The reservoir shall be filled, and complete application of the stored water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The storage of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
