THIS PERMIT IS HEREBY ISSUED TO

to construct LINCOLN RESERVOIR and store the waters of AN UNNAMED STREAM, a tributary of LITTLE PUDDING RIVER, to be maintained and appropriated under Application 69793, Permit 50972, for IRRIGATION AND FISH CULTURE.

This Permit is issued approving Reservoir Application R-69792. The date of priority is DECEMBER 28, 1988. The amount of water entitled to be stored each year is not more than 1.0 ACRE-FOOT, BEING 0.5 AF FOR IRRIGATION AND 0.5 AF FOR FISH CULTURE.

The dam will be located as follows:

NW 1/4 NW 1/4, SECTION 3, T 8 S, R 2 W, W.M.

The area submerged by the reservoir, when full, will be 0.1 acre and the maximum depth of water will be 10.0 feet.

The area to be submerged by the reservoir is located within:

NW 1/4 NW 1/4 SECTION 3 TOWNSHIP 8 SOUTH, RANGE 2 WEST, W.M.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provisions of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Actual construction work shall begin on or before MAY 18, 1991, and shall be completed on or before October 1, 1992. The reservoir shall be filled, and complete application of the stored water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

The permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
