THIS PERMIT IS HEREBY ISSUED TO:

to construct FIVE RESERVOIRS and to store the waters of UNNAMED SPRINGS, a tributary of UMPQUA RIVER, to be appropriated under Application 69571, Permit 51211, for IRRIGATION, SUPPLEMENTAL IRRIGATION AND DOMESTIC USE FOR TWO FAMILIES.

This permit is issued approving Reservoir Application R-69571. The date of priority is JUNE 14, 1990. The amount of water entitled to be stored each year is not more than 11.46 ACRE-FEET, BEING 2.5 AF IN RESERVOIR A, 1.40 AF IN RESERVOIR B, 2.0 AF IN RESERVOIR C, 5.524 AF IN RESERVOIR D AND 0.0307 AF IN RESERVOIR E.

The dams will be located as follows:

RESERVOIR A - SE 1/4 NW 1/4, 1850 FEET SOUTH AND 3350 FEET EAST;
RESERVOIR B - SW 1/4 NE 1/4, 1750 FEET SOUTH AND 2925 FEET EAST;
RESERVOIR C - SW 1/4 NE 1/4, 1375 FEET SOUTH AND 2875 FEET EAST;
RESERVOIR D - SE 1/4 NW 1/4, 1250 FEET SOUTH AND 2275 FEET EAST;
RESERVOIR E - SE 1/4 NW 1/4, 1450 FEET SOUTH AND 2200 FEET EAST;
ALL IN SECTION 10, ALL FROM NW CORNER SECTION 10, T 25 S, R 7 W, W.M.

The area submerged by the reservoirs, when full, will be Reservoir A - 0.58 acre; Reservoir B - 0.324 acre; Reservoir C - 0.29 acre; Reservoir D - 1.30 acre; Reservoir E - 0.009 acre and the maximum depth of water will be Reservoir A - 9.9 feet; Reservoir B - 12.0 feet; Reservoir C - 9.9 feet; Reservoir D - 12.0; Reservoir E - 7.0 feet.

The area to be submerged by the reservoir is located within:

SE 1/4 NW 1/4 Reservoir A
SW 1/4 NE 1/4 Reservoirs B & C
SE 1/4 NW 1/4 Reservoirs D & E
SECTION 10
TOWNSHIP 25 SOUTH, RANGE 7 WEST, W.M.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provisions of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Actual construction work shall begin on or before April 8, 1992, and shall be completed on or before October 1, 1993. The reservoir shall be filled and complete application of the stored water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

The permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
