STORE FOR BENEFICIAL USE THE PUBLIC WATERS

to construct RESERVOIRS 1, 2, AND 4 THROUGH 12 and store the waters of AN UNNAMED DRAINAGEWAY, UNNAMED STREAMS 1, 2, 3, AND FERRY CREEK, tributaries of COQUILLE RIVER, to be appropriated under Application 69641, Permit 51371, for CRANBERRY OPERATIONS.

This Permit is issued approving Reservoir Application R-69640. The date of priority is JUNE 13, 1988. The amount of water entitled to be stored each year is not more than 63.66 ACRE-FEET(AF): BEING 7.99 AF IN RESERVOIR 1, 3.55 AF IN RESERVOIR 2, 9.04 AF IN RESERVOIR 4, AND 6.2 AF IN RESERVOIR 5 FROM AN UNNAMED DRAINAGEWAY; 4.64 AF IN RESERVOIR 6 FROM UNNAMED STREAM 1; 9.0 AF IN RESERVOIR 7, 9.04 AF IN RESERVOIR 8, AND 3.1 AF IN RESERVOIR 9 FROM UNNAMED STREAM 2; 6.3 AF IN RESERVOIR 10 FROM UNNAMED STREAM 3; 2.32 AF IN RESERVOIR 11 AND 2.48 AF IN RESERVOIR 12 FROM FERRY CREEK.

The dams will be located as follows:

RESERVOIR 8 - NE 1/4 SW 1/4; RESERVOIRS 6 & 7 - NW 1/4 SW 1/4; RESERVOIR 9 - SW 1/4 SW 1/4; RESERVOIRS 1, 2, 4 & 5 - SW 1/4 SE 1/4; SECTION 20, RESERVOIR 13 - NW 1/4 NE 1/4, RESERVOIR 10 & 11 - NW 1/4 NW 1/4, RESERVOIR 12 - SW 1/4 NW 1/4, SECTION 29, T 28 S, R 14 W, W.M.

The area submerged by the reservoirs, when full, will be RESERVOIR 1, 1.01 ACRES, RESERVOIR 2, 0.46 ACRE, RESERVOIR 4, 1.01 ACRES, RESERVOIR 5, 0.69 ACRE, RESERVOIR 6, 0.51 ACRE, RESERVOIR 7, 1.0 ACRE, RESERVOIR 8, 1.0 ACRE, RESERVOIR 9, 0.34 ACRE, RESERVOIR 10, 0.70 ACRE, RESERVOIR 11, 0.26 ACRE AND RESERVOIR 12, 0.27 ACRE and the maximum depth of water will be 9.0 feet in each reservoir.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provisions of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Actual construction work shall begin on or before November 25, 1992, and shall be completed on or before October 1, 1993. The reservoir shall be filled, and complete application of the stored water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

The permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The storage of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
