SOURCE OF WATER: AN UNNAMED STREAM, A TRIBUTARY OF DREWS CREEK, WITHIN THE GOOSE AND SUMMER LAKES BASIN

STORAGE FACILITY: TWO UNNAMED RESERVOIRS

PURPOSE OR USE OF THE STORED WATER: LIVESTOCK WATERING

RATE/VOLUME: 0.172 ACRE-FEET EACH YEAR, BEING 0.086 AC-FT IN EACH RESERVOIR

PERIOD OF ALLOWED USE: November 1 through April 30

DATE OF PRIORITY: September 20, 1994

The area submerged by Reservoir 1, when full, will be 0.014 acre and the maximum depth of water will be 6.0 feet. The maximum height of the dam shall not exceed 2.0 feet.

The area submerged by Reservoir 2, when full, will be 0.014 acre and the maximum depth of water will be 6.0 feet. The maximum height of the dam shall not exceed 2.0 feet.

DAM LOCATION: NW 1/4 SE 1/4, SW 1/4 SE 1/4, SECTION 7, T 40 S, R 19 E, W.M.; #1 - NORTH 45 1/4 DEGREES WEST 2953.5 FEET, #2 - NORTH 62 1/4 DEGREES WEST 1914.0 FEET, BOTH FROM THE SE CORNER OF SECTION 7

THE AREA TO BE SUBMERGED BY THE RESERVOIRS IS LOCATED AS FOLLOWS:

SW 1/4 SE 1/4

SECTION 7

TOWNSHIP 40 SOUTH, RANGE 19 EAST, W.M.

Measurement recording and reporting conditions:

- A. The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director.

If the Director notifies the permittee to install a meter or other measuring device, the permittee shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the permittee to submit alternative measuring procedures for review and approval.

- B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The permittee may be required in the future to install, maintain, and operate fish screening and by-pass devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the proposed diversion.

Use under this permit is limited to the reservoir area. This permit does not provide for the appropriation of water for maintaining the water level or maintaining a suitable fresh water condition from May 1 through October 31 of each year.

STANDARD CONDITIONS

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provision of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.


By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin within one year from permit issuance and shall be completed on or before October 1, 1997. The reservoir shall be filled and complete application of the stored water to the use shall be made on or before October 1, 1998.
