The specific limits for the use are listed below along with conditions of use.

APPLICATION FILE NUMBER: R-76190

SOURCE OF WATER: AN UNNAMED SPRING WITHIN THE GRANDE RONDE BASIN

STORAGE FACILITY: ONE UNNAMED RESERVOIR

PURPOSE OR USE OF THE STORED WATER: LIVESTOCK

VOLUME OF USE: 2.2 ACRE-FEET EACH YEAR

PERIOD OF ALLOWED USE: YEAR ROUND

DATE OF PRIORITY: DECEMBER 27, 1994

The area submerged by the reservoir, when full, will be 0.22 acre and the maximum depth of water will be 10.0 feet. The maximum height of the dam shall not exceed 0.0 feet.

DAM LOCATION: NW 1/4 SW 1/4, SECTION 10, T2S, R38E, W.M.; 1418 FEET NORTH AND 788 FEET EAST FROM THE SW CORNER OF SECTION 10

THE AREA TO BE SUBMERGED BY THE RESERVOIR IS LOCATED AS FOLLOWS:

NW 1/4 SW 1/4
SECTION 10
TOWNSHIP 2 SOUTH, RANGE 38 EAST, W.M.

Measurement recording and reporting conditions:

- A. The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the permittee to install a meter or other measuring device, the permittee shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the

watermaster access to the meter or measuring device. The Director may provide an opportunity for the permittee to submit alternative measuring procedures for review and approval.

- B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The use of water allowed herein may be made only at times when waters from the spring do not flow into a tributary of Grande Ronde River or sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows

STANDARD CONDITIONS

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.


The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin within one year from permit issuance and shall be completed on or before October 1, 1998. The reservoir shall be filled and complete application of the water to the use shall be made on or before October 1, 1999.
