

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Clarence Lindow (Name of Applicant)

of P 2 Box 226 A Hillsboro (Mailing Address)

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Lindow Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Unnamed stream

tributary of Tualatin River

3. The amount of water to be stored is 1,125,000 Gallons (4.6 a.f.) acre-foot.

4. The use to be made of the impounded water is irrigation (irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. NE 1/4 SE 1/4, Sec 33 (Give sections or townships to be submerged)

Tp. 15, R. 2 W, W. M., in the county of Washington

(a) State whether situated in channel of running stream and give character of material at outlet

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions in channel of stream

6. The dam will be located in NE 1/4 SE 1/4, Sec. 33 (Smallest legal subdivision)

Tp. 15, R. 2 W, W. M. The maximum height will be 9 feet above stream bed or ground surface on center line of dam. The length on top will be 125 feet; length on bottom 10 feet; width on top 14 feet; slope of front or water side 3:1 (Feet horizontal to 1 vertical); slope on back 2:1 (Feet horizontal to 1 vertical); height of dam above water line when full 1.0 feet.

* A different form of application should be used for the appropriation of stored water to beneficial use. Such forms can be secured without charge, together with instructions, by addressing the State Engineer, Salem, Oregon.

13. Construction work will be completed on or before October 1 1951
