SOURCE OF WATER: AN UNNAMED STREAM AND EAST FORK DAIRY CREEK

STORAGE FACILITY: DUYCK RESERVOIR

PURPOSE OR USE OF THE STORED WATER: TO BE APPROPRIATED UNDER PERMIT 53547 FOR SUPPLEMENTAL IRRIGATION.

QUANTITY: 8.63 ACRE-FEET EACH YEAR

WATER MAY BE APPROPRIATED FOR STORAGE DURING THE PERIOD: NOVEMBER 1 THROUGH JUNE 30 OF EACH YEAR EXCEPT AS FURTHER LIMITED BELOW.

During the months of May and June of each year water use authorized under this permit shall only be allowed when streamflow in the Tualatin River is 250 cfs or greater as measured at gage #14206500 on the Tualatin River near Farmington.

DATE OF PRIORITY: FEBRUARY 19, 1991

The area submerged by the reservoir, when full, will be 1 acre and the maximum depth of water will be 12 feet. The reservoir is excavated; there is no dam.

POINT OF DIVERSION: SE 1/4 SW 1/4, SECTION 26, T2N, R3W, W.M.; 725 FEET NORTH & 1630 FEET EAST FROM SW CORNER, SECTION 26.

## STANDARD CONDITIONS

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provision of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin by March 15, 2000. Complete application of water to the use shall be made on or before October 1, 2003. Within one year after complete application of water to the proposed use, the permittee shall submit a claim of beneficial use, which includes a map and report, prepared by a Certified Water Rights Examiner (CWRE).
