APPLICATION FILE NUMBER: R-84309

SOURCE OF WATER: AN UNNAMED STREAM, A TRIBUTARY OF SOUTH UMPQUA RIVER

STORAGE FACILITY: UPPER RESERVOIR

PURPOSE OR USE OF THE STORED WATER: AQUATIC LIFE, RECREATION AND WILDLIFE

MAXIMUM STORAGE VOLUME: 2.4 ACRE-FEET EACH YEAR

WATER MAY BE APPROPRIATED FOR STORAGE DURING THE PERIOD: NOVEMBER 1 THROUGH JULY 14 OF EACH YEAR

DATE OF PRIORITY: DECEMBER 13, 1999

THE MAXIMUM HEIGHT OF THE DAM SHALL NOT EXCEED 10.00 FEET.

DAM LOCATION: NESW, SECTION 34, T26S, R6W, W.M.;

THE AREA TO BE SUBMERGED BY THE RESERVOIR IS LOCATED AS FOLLOWS:
NESW SECTION 34 TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

Measurement, recording and reporting conditions:

- A. The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the permittee to install a meter or other measuring device, the permittee shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the

watermaster access to the meter or measuring device. The Director may provide an opportunity for the permittee to submit alternative measuring procedures for review and approval.

- B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

No overland flow due to excessive irrigation is allowed.

If the reservoir is stocked with fish, adequate screening must be in place to prevent escape into the South Umpqua River.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provision of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Use under this permit is limited to the reservoir area. This permit does not provide for the appropriation of water for maintaining the water level or maintaining a suitable fresh water condition.


The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

Actual construction work shall begin by July 30, 2001. The reservoir shall be filled and complete application of the stored water to the use shall be made on or before October 1, 2004. Within one year after complete application of water to the proposed use, the permittee shall submit a claim of beneficial use, which includes a map and report.
