Application for Permit to Construct a Reservoir and to Store for Irrigation Use the Unappropriated Waters of the State of Oregon

WILLIAM L. PERRY

RE. 67, McMinnville, Oregon

I, WILLIAM L. PERRY, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Ferry Irrigation Project

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Unnamed Creek

tributary of Cubins Creek and tributary of Tumalo River

3. The amount of water to be stored is 4 acre feet.

4. The use to be made of the impounded water is IRRIGATION

5. The location of the proposed reservoir will be in Sec. part 4 of the 1/4 sec. 30

Td. 4 South, R. 4 West, W. M., in the county of Wasco

(a) State whether situated in channel of running stream and give character of material at outlet
Yes, in unnamed creek, concrete spillway

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions

6. The dam will be located in S.E. 1/4 of the 1/4 Sec. 30

The maximum height will be 9 feet above stream bed or ground surface on center line of dam. The length on top will be 195 feet; length on bottom 210 feet; width on top 11 feet; slope of front or water side 2 1/2 : 1; slope on back 2 : 1; height of dam above water line when full Min. 2 feet
