

Application for a Permit to Construct a Reservoir and to Store the Unappropriated Waters of the State of Oregon

of R. T. I. Box 201, Clackamas, Oregon

State of OREGON, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is UANNOSE

2. The name of the stream from which the reservoir is to be filled and the appropriation made is UANNOSE

tributary of Clackamas River

3. The amount of water to be stored is 5 acre feet

4. The use to be made of the impounded water is Irrigation, fish culture (irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 17

Tp. 3 S., R. 3 E., W. M., in the county of Clackamas

(a) State whether situated in channel of running stream and give character of material at outlet

in channel of running stream wooden outlet

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions

6. The dam will be located in NW 1/4 SE 1/4 Sec. 17

The maximum height will be 10 feet above stream bed or ground surface on center line of dam. The length on top will be 100 feet; length on bottom 60 feet; width on top 10 feet; slope of front or water side 2 (feet horizontal to 1 vertical); slope on back 1 (feet horizontal to 1 vertical); height of dam above water line when full 2 feet.

\* A different form of application should be used for the appropriation of stored water to beneficial use. Such forms can be secured without charge, together with instructions, by addressing the State Engineer, Salem, Oregon.

7. The character of dam, the material of which it is to be built, and method of protection from waves are as follows: Earth filled - constructed by "cut"

8. The location of roadway with dimensions are as follows: low point on south side of reservoir provides natural washway, flowing across grass sod into 2' x 2' ditch, 1/4 of distance across reservoir from dam

9. The location of outlet from the proposed reservoir, with character of construction and dimensions are as follows: Washway outlet, around side of dam 2' x 2' extends to bed of stream with stage obtained by use of trestleboards

10. The area submerged by the proposed reservoir, when full, will be 1/2 acres, with a maximum depth of water of 14 feet; and approximate mean depth of water 10 feet.

- 11. The estimated cost of the proposed work is \$ 500.00
- 12. Construction work will begin on or before Sept. 1, 1952
- 13. Construction work will be completed on or before Oct. 1, 1952
