

Application for Permit to Construct a Reservoir and to Store the Unappropriated Waters of the State of Oregon

I, Fred Gibson, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Gibson

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Gibson Gulch, tributary of Winslow Gulch trib of Willamette River

3. The amount of water to be stored is 15.9 acre feet

4. The use to be made of the impounded water is irrigation

5. The location of the proposed reservoir will be in Sec 12, Tp 15 R 4 W W M, in the county of Polk

(a) State whether situated in channel of running stream and give character of material at outlet in channel

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions

6. The dam will be located in NW 1/4 Sec 12, Tp 15 R 4 W W M

The maximum height will be 7.4 feet above stream bed or ground surface on center line of dam. The length on top will be 250 feet, length on bottom 311 feet, width on top 10 feet; slope of front or water side 3:1; slope on back 2:1; height of dam above water line when full 2 feet

A different form of application should be used for the appropriation of stored water to beneficial use. Such forms can be secured without charge, together with instructions, by addressing the State Engineer, Salem, Oregon.

WITH A MAXIMUM DEPTH OF WATER OF 6.2 FEET; AND APPROXIMATE MEAN DEPTH OF WATER 2.8 FEET.
