

**Application for a Permit to Construct a Reservoir and to
Store the Unappropriated Waters of the State of Oregon**

State of OREGON, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights:

The priority date of this permit is December 29, 1952

Actual construction work shall begin on or before August 21, 1954

and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1955
