

Reservoir Permit No. 1698

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, T. J. Shipler (Name of Applicant)

of Route 8, Box 44 (Glenn Creek Road) Salem (Mailing Address)

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is unnamed

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Glenn Creek

tributary of Willamette River

3. The amount of water to be stored is 7.11 4-0 AC. acre feet.

4. The use to be made of the impounded water is irrigation (Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 19 Tp. 7 South, R. 3 West, W. M., in the county of Polk (Give sections or townships to be submerged)

(a) State whether situated in channel of running stream and give character of material at outlet red clay

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions

6. The dam will be located in S.E. 1/4 of N.E. 1/4, Sec. 19, Tp. 7 South, R. 3 West, W. M. The maximum height will be 10 feet above stream bed or ground surface on center line of dam. The length on top will be 200 feet; length on bottom 20 feet; width on top 10 feet; slope of front or water side 3:1; slope on back 2:1; height of dam above water line when full 3 feet.

* A different form of application should be used for the appropriation of stored water to beneficial use. Such forms can be secured without charge, together with instructions, by addressing the State Engineer, Salem, Oregon.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Rolled earth-fill dam, protected by log buffers

8. The location of wasteway with dimensions are as follows: around South end of dam with
(State whether over or around the dam)
1/2-foot bottom, 2:1 side slopes, and 40-foot top width.

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: 18" concrete sewer tile with mastic joint material.
(All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time.)

10. The area submerged by the proposed reservoir, when full, will be about 2/3 acres, with a maximum depth of water of 7 feet; and approximate mean depth of water 4 feet.

11. The estimated cost of the proposed work is \$ 2,000.00

12. Construction work will begin on or before August 1, 1955

13. Construction work will be completed on or before October 1, 1955
