

*Reservoir Permit No. 2373

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Bureau of Land Management (Name of Applicant)

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Mahoghany Reservoir, project 02-995, completed 9/1/59

2. The name of the stream from which the reservoir is to be filled and the appropriation made is tributary of Squaw Creek

3. The amount of water to be stored is .48 acre feet.

4. The use to be made of the impounded water is livestock (Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 26 (Give sections or townships to be submerged)

Tp. 18S, R. 35E, W.M., in the county of Harney

(a) State whether situated in channel of running stream and give character of material at outlet intermittent stream

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions surface runoff

6. The dam will be located in NW 1/4 NE 1/4 Sec. 20, Tp. 18S, R. 35E, W.M. The maximum height will be 7 feet above stream bed or ground surface on center line of dam. The length on top will be 180 feet; length on bottom 60 feet; width on top 10 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 3 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: earth fill excavated from the catch basin

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Mahoghany Reservoir and storage of water from Squaw Creek for livestock watering purposes.

The right of storage of water as granted herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 0.48 acre feet.

The priority date of this permit is February 18, 1960

Actual construction work shall begin on or before September 20, 1961 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1962.
