

Reservoir Permit No. 2517

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, William Schafer (Name of Applicant)

of River Road S Salem (Mailing Address)

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Un named reservoir on Wm. Schafer farm.

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Unnamed drainage ditch tributary of Pudding River

3. The amount of water to be stored is Maximum 1 acre foot acre feet.

4. The use to be made of the impounded water is Irrigation (Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 9 NE 1/4 of SW 1/4 (Give sections or townships to be submerged)

Tp. 6S, R. 1W, W. M., in the county of Marion

(a) State whether situated in channel of running stream and give character of material at outlet Not in channel of running stream

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions Sump will be filled through a feed canal. Bottom width 3' top width 20' Depth 6' ave.

6. The dam will be located in NE 1/4 of SW 1/4, Sec. 9 (Smallest legal subdivision)

Tp. 6S, R. 1W, W. M. The maximum height will be feet above stream bed or ground surface on center line of dam. The length on top will be feet; length on bottom feet; width on top feet; slope of front or water side; slope on back; height of dam above water line when full feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Excavated sump— no protection necessary

8. The location of wasteway with dimensions are as follows: none

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: none
(All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time.)

10. The area submerged by the proposed reservoir, when full, will be 6,000 sq. ft. acres, with a maximum depth of water of 12' feet; and approximate mean depth of water 8.6 feet.

11. The estimated cost of the proposed work is \$ 600

12. Construction work will begin on or before July 25, 1960

13. Construction work will be completed on or before July 31, 1961
