### Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Lincon Bench Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Un-named  
tributary of Crocker

3. The amount of water to be stored is ~~659~~ 78 acre feet.

4. The use to be made of the impounded water is irrigation

6. The dam will be located in 20, Sec. 20  
(Smallest legal subdivision)  
Tp. 10S., R. 10E., W.M. The maximum height will be 6 feet above stream bed or ground surface on center line of dam. The length on top will be 60 feet; length on bottom 100 feet; width on top 10 feet; slope on front or water side 3:1; slope on back 3:1; height of dam above water line when full 6 feet.

The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: A roadway will be dug and filled with the best available material to be put in front of the reservoir. The dam will be built in the center to exceed 7 inches and on each side a concrete overflow wall. The dam will be riprapped if necessary.

The right of storage of water as granted herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 2.78 acre feet.

shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1963
