

Reservoir Permit No. 2850

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

T. 23S R. 17E W.M. The maximum height will be 9 feet above stream bed or ground surface on center line of dam. The length on top will be 350 feet; length on bottom 370 feet; width on top 14 feet; slope on front or water side 3; slope on back 2; height of dam above water line when full 4 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Existing structure was constructed with dozer and/or carryall with materials available at project site. No wave of protection is necessary.

8. The location of wasteway with dimensions are as follows: Around end of dam 10 feet wide and 2 feet deep.

9. The location of outlet from the existing proposed reservoir, with character of construction and dimensions, are as follows: See remarks

10. The area submerged by the existing proposed reservoir, when full, will be 3 acres. with a maximum depth of water of 7 feet; and approximate mean depth of water 1 feet.

This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions: The right herein granted is limited to the construction of East Walker Reservoir and storage of water from an unnamed stream for livestock. The right of storage of water as granted herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 3.0 acre feet.

Actual construction work shall begin on or before June 17, 1963 and

shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1964.
