State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

Tp. 23S, R. 17E, W.M. The maximum height will be 9 feet above stream bed or ground surface on center line of dam. The length on top will be 210 feet; length on bottom 200 feet; width on top 11 feet; slope on front or water side 3; slope on back 2; height of dam above water line when full 2 feet.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Division Reservoir and storage of water from an unnamed intermittent stream for stock and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 2.0 acre feet.

The priority date of this permit is July 24, 1961

Actual construction work shall begin on or before September 24, 1963 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1964
