7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Dam constructed with an angle dozer of the soil at the immediate site. No protection from wave action is required due to its small size.

8. The location of wasteway with dimensions are as follows: around dam on the south end.

It is 12 ft. wide and 2 feet deep.

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: See 8 above. Spillway exceeds inflowing channel several times  
(All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time)  
in width.

10. The area submerged by the proposed reservoir, when full, will be less than 1/10 acres, with a maximum depth of water of 3 feet; and approximate mean depth of water 2 feet.

11. The estimated cost of the proposed work is \$ 140.00

12. Construction work will begin on or before constructed under the authority of the Taylor Grazing Act of 1934 before BLM was required to make a water filing.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of South Baldy Reservoir No. 2 and storage of water from Baldy Creek for stock and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 0.2 acre feet.

The priority date of this permit is July 20, 1961

Actual construction work shall begin on or before June 24, 1964 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1965.
