Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Pierce Waterhole 0-6-415

2. The name of the stream from which the reservoir is to be filled and the appropriation made is an unnamed tributary of Pritchard Creek

3. The amount of water to be stored is 0.01 acre feet.

4. The use to be made of the impounded water is Stockwater
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 10

6. The dam will be located in SW $\frac{1}{4}$ SW $\frac{1}{4}$, Sec. 10,
(Smallest legal subdivision)
Tp. 10 S, R. 42 E, W.M. The maximum height will be 4 feet above stream bed or ground surface on center line of dam. The length on top will be 84 feet; length on bottom 45 feet; width on top 1 feet; slope on front or water side 3.2:1; slope on back 2:1; height of dam above water line when full 1.5 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Built of native earth material. No wave protection other than 3:1 slope.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Pierce Waterhole and storage of water from an unnamed tributary of Pritchard Creek for stockwater.

The right of storage of water as granted herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 0.01 acre feet.

Actual construction work shall begin on or before August 9, 1964 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1965
