Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

6. The dam will be located in Section 5, Sec. 5,
(Smallest legal subdivision)

Tp. 22S., R. 44E., W.M. The maximum height will be 6 feet above stream bed or ground surface on center line of dam. The length on top will be 15 feet; length on bottom triangular feet; width on top 15 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 3 feet.

The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: A keyway will be dug and filled with concrete material taken from a pit in front of the dam. The dam will be built in layers not to exceed 6 inches and compacted with a steam powered roller. The dam will be raised if necessary.

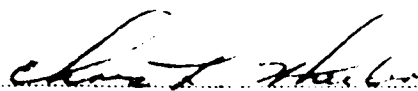
This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Grassy Mountain Reservoir and storage of water from an unnamed stream for livestock and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 0.04 acre feet.

The priority date of this permit is August 8, 1961

Actual construction work shall begin on or before November 5, 1964 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1965.
