Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Grain Creek Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Un-named

3. The amount of water to be stored is 1,000 acre feet.

4. The use to be made of the impounded water is stock water only

The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: A keyway will be dug and filled with the best material taken from a pit in front of the reservoir. The dam will be built in layers not to exceed 4 inches and compacted with a heavy carryall. The dam will be riprapped if necessary.

subject to the following limitations and conditions: The right herein granted is limited to the construction
of Johnston Gulch Reservoir and storage of water from an unnamed stream for live-
stock, and is subject to the installation and maintenance of an outlet pipe, or to
provide other means to evacuate the stored water when determined by the state
engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 1.2 acre feet.

shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1965.
