### Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

6. The dam will be located in NE 1/4 NE 1/4, Sec. 33,

Tp. 27 S., R. 24 E., W.M. The maximum height will be 7 feet above stream bed or ground surface on center line of dam. The length on top will be 160 feet; length on bottom 150 feet; width on top 10 feet; slope on front or water side 3; slope on back 2; height of dam above water line when full 2 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Existing structure was constructed with dozer and/or carryall with materials found at project site. No wave protection is necessary

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: See remarks

10. The area submerged by the proposed reservoir, when full, will be 0.5 acres, with a maximum depth of water of 6 feet; and approximate mean depth of water 4 feet.

11. The estimated cost of the proposed work is \$14,690

The right hereunder shall be limited to the storage of 2.0 acre feet.
