Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, W. J. Cody (Name of Applicant)

of Rt. 1 Box 116, Tygh Valley (Mailing Address)

State of Oregon do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Stock Pond # 4

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Run off water from surrounding topography tributary of Would eventually drain into Rock Creek

3. The amount of water to be stored is 9 1/2 9.13 acre feet

4. The use to be made of the impounded water is stock pond irrigation 0.5 AF to be reserved for livestock (Sec. 18)

5. The location of the proposed reservoir will be in Sec. 18 Tp. 4S R. 11E, W.M., in the county of Wasco

(a) State whether situated in channel of running stream and give character of material at outlet no stream

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions filled during winter runoff

6. The dam will be located in Sw 1/4 of NW 1/4 Sec. 18 Tp. 4S R. 11E, W.M. The maximum height will be 10 feet above stream bed or ground surface on center line of dam. The length on top will be 1080 feet; length on bottom 1080 feet; width on top 10 feet; slope on front or water side 3-1; slope on back 2-1; height of dam above water line when full 2 feet.

* A different form of application should be used for the appropriation of stored water to beneficial use. Such forms can be secured without charge, together with instructions, by addressing the State Engineer, Salem, Oregon.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Built with D8 Cat. and No 80 scraper
No riprap other than rocks that came out of excavation area

8. The location of wasteway with dimensions are as follows: around the dam
(State whether circular around the dam)
6ft. wide ditch

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: no outlet needed.
(All dams across natural stream channels must be provided with an outlet conduit of such capacity and location to pass the normal flow of the stream at any time)

10. The area submerged by the proposed reservoir, when full, will be 2.2 acres.
with a maximum depth of water of 8.0 feet and approximate mean depth of water 4.15 feet.

11. The estimated cost of the proposed work is \$ 2,000.00

12. Construction work will begin on or before August 1, 1963

13. Construction work will be completed on or before

July 1, 1964

This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions: The right herein granted is limited to the construction of Cody Pond No. 4 and storage of water from runoff from surrounding terrain for stock, fish culture and wildlife propagation; being 0.5 acre foot for stock and 8.63 acre feet for fish culture and wildlife propagation.

The right hereunder shall be limited to the storage of 9.13 acre feet

The priority date of this permit is October 22, 1963

Actual construction work shall begin on or before June 19, 1965 and

shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1966. Complete application of water to the proposed use shall be made on or before Oct. 1, 1967.
