Reservoir Permit No. 4004

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Bureau of Land Management (Name of Applicant)

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Green Reservoir 02-787

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed tributary of Little Trout Creek

3. The amount of water to be stored is .25 acre feet.

4. The use to be made of the impounded water is livestock (Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 20 Tp. 39S R. 38E, W.M., in the county of Harney (Give sections or townships to be submerged)

(a) State whether situated in channel of running stream and give character of material at outlet In channel of drainage of intermittent stream.

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions

6. The dam will be located in SW SE, Sec. 20 Tp. 39S R. 38E, W.M. The maximum height will be 10 feet above stream bed or ground surface on center line of dam. The length on top will be 75 feet; length on bottom 55 feet; width on top 14 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 3 feet.

* A different form of application should be used for the appropriation of stored water to beneficial use. Such forms can be secured without charge together with instructions by addressing the State Engineer, Salem, Oregon.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Earth excavated from catch basin.

8. The location of wasteway with dimensions are as follows: Around end of structure.

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: None

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Green Reservoir and storage of water from an unnamed stream for livestock and is subject to the installation and maintenance of an outlet pipe or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 0.25 acre feet.
