length on top will be 320 feet; length on bottom 40 feet; width on top 12 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 3.0 feet.

Remarks: Fish culture is planned to be the planting of 1,500 warm water type fish which will be harvested for personal use by hook and line. Facilities will be installed so that the reservoir can be used for swimming, boating, picnicing, etc.

~~Due to the withdrawal of Croisan Creek from direct flow appropriation, it is understood that all seepage and evaporation losses in the reservoir will come from stored water only.~~ REF

CROISAN CREEK will be RECHANNLED AROUND POND AND old channel will be EARTH filled. Pond will be filled thru new 10" pipe with gate valve. REF
