Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the ~~proposed~~ reservoir is Howard Prairie Reservoir.

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Tributary of Jenny Creek which is
tributary of the Klamath River.

3. The amount of water to be stored is less than 1/4 acre feet.

4. The use to be made of the impounded water is stock water purpose.

5. The location of the proposed reservoir will be in Sec. 35

6. The dam will be located in Howard Prairie, (Smallest legal subdivision), Sec. 35,
Tp. 2, R. 2, W.M. The maximum height will be 12 feet above stream bed or ground surface on center line of dam. The length on top will be 100 feet; length on bottom 100 feet; width on top 10 feet; slope on front or water side 1 to 1; slope on back 1 to 1; height of dam above water line when full 12 feet.


The right hereunder shall be limited to the storage of 0.25 acre feet.
