# Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

2. The name of the stream from which the reservoir is to be filled and the appropriation made is A lateral of Keene Creek which is a

tributary of Keene Creek

The length on top will be 100 feet; length on bottom 100 feet; width on top 10 feet; slope of front or water side 1:1; slope on back 1:1; height of dam above water line when full 10 feet.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Sandcore Pass Reservoir and storage of water from an unnamed tributary of Keene Creek for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of .20 acre feet.

The priority date of this permit is December 22, 1960

Actual construction work shall begin on or before September 10, 1965 and

shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1966.
