Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed

Tp. 298, R. 31E, W.M. The maximum height will be 8 feet above stream bed or ground surface on center line of dam. The length on top will be 50 feet; length on bottom 35 feet; width on top 12 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 3 feet.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Buena Vista waterhole Reservoir and storage of water from an unnamed stream for livestock and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 0.35 acre feet.
