# Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is White Wash res.

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed

tributary of Owyhee river

3. The amount of water to be stored is 4.07 acre feet.

4. The use to be made of the impounded water is stock water only  
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 2  
(Give sections or townships to be submerged)

6. The dam will be located in SE 1/4, Sec. 2  
(Smallest legal subdivision)

Tp. 29S., R. 41E., W. M. The maximum height will be 2 feet above stream bed or ground surface on center line of dam. The length on top will be 300 feet; length on bottom triangular feet; width on top 12 feet; slope of front or water side 1:1; slope on back 2:1; height of dam above water line when full 2 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: a keyway will be dug and filled with the best impervious material taken from a pit in front of the reservoir. The dam will be built in layers not to exceed 6 inches and compacted with a cat and carryall. The cat will be riprapped if necessary.

8. The location of wasteway with dimensions are as follows: (State whether over or around the dam.)

9. The location of outlet from the proposed reservoir, with character of construction and dimensions are as follows: None (see remarks)

(All dams across natural stream channels must be provided with an outlet conduit of such capacity and location to pass the

10. The area submerged by the proposed reservoir, when full, will be 44.4 acres, with a maximum depth of water of 5 feet; and approximate mean depth of water 1.67 feet.
