# Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Bureau of Land Management (Name of Applicant)

of P. O. Box 338, Vale, Oregon (Mailing Address)

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

- 1. The name of the proposed reservoir is Anawalt Res.
- 2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed tributary of Owyhee river
- 3. The amount of water to be stored is 2.34 acre feet.
- 4. The use to be made of the impounded water is stock water only (Irrigation, power, domestic supply, etc.)
- 5. The location of the proposed reservoir will be in Sec. 2 (Give sections or townships to be submerged) Tp. 29S., R. 41E., W. M., in the county of Malheur.

(a) State whether situated in channel of running stream and give character of material at outlet not a running stream; rock and clay spillway

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions from spring runoff

- 6. The dam will be located in (Lot 7) Sec. 2 (Simplest legal subdivision) Tp. 29S., R. 41E., W. M. The maximum height will be 9 feet above stream bed or ground surface on center line of dam. The length on top will be 400 feet; length on bottom triangular feet; width on top 12 feet; slope of front or water side 3:1 feet horizontal to 1 vertical; slope on back 2:1 feet horizontal to 1 vertical; height of dam above water line when full 4 feet.

\* A different form of application should be used for the appropriation of stored water to beneficial use. Such forms can be obtained without charge, together with instructions, by addressing the State Engineer, Salem, Oregon.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: a keyway will be dug and filled with the best impervious material taken from a pit in front of the reservoir. The dam will consist of layers not to exceed 5 inches and compacted with a cammed roller. The dam will be riprapped if necessary.

8. The location of wasteway with dimensions are as follows: spillway built around end of dam.

9. The location of outlet from the proposed reservoir, with character of construction and dimensions are as follows: none see remarks. (All dams across natural stream channels must be provided with an outlet conduit of such capacity and location to pass the normal flow of the stream at any time.)

10. The area submerged by the proposed reservoir, when full, will be 1.53 acres. with a maximum depth of water of 1.53 feet; and approximate mean depth of water 1.53 feet.

The right hereunder shall be limited to the storage of 2.34 acre feet.
