Tr. 3 South R. 5 West W.M. The maximum height will be 10 feet above stream bed or ground surface on center line of dam. The length on top will be about 100 feet; length on bottom about 50 feet; width on top 10 feet; slope on front or water side 3 to 1; slope on back 2 to 1; height of dam above water line when full 3 1/2 feet.

9. The location of outlet from the proposed reservoir with character of construction and dimensions are as follows: 6 inch steel pipe with gate valve in bottom of dam and a concrete spillway 2 1/2 feet by 2 feet around the dam.

10. The area submerged by the proposed reservoir will be about 1/2 acre with a maximum depth of water of 7 feet and approximate average depth of water 4 feet.
