State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the proposed reservoir is Beltview Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is runoff from
tributary of North Yamhill

3. The amount of water to be stored is 4 acre feet.

4. The use to be made of the impounded water is Fish culture
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 25

6. The dam will be located in N. 1/2 of Sec. 25,
(Smallest legal subdivision)
Tp. 2S, R. 5W, W.M. The maximum height will be 6 feet above stream bed or ground surface on center line of dam. The length on top will be 800 feet; length on bottom 800 feet; width on top 8 feet; slope on front or water side 3-1; slope on back 2-1; height of dam above water line when full 2 1/2 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Material used will be dirt taken from the excavation to deepen water

10. The area submerged by the proposed reservoir, when full, will be 1 1/3 acres, with a maximum depth of water of 8 feet; and approximate mean depth of water 3 feet.

11. The estimated cost of the proposed work is \$ 900⁰⁰

12. Construction work will begin on or before Dec 1 - 64

13. Construction work will be completed on or before Oct 1 - 65
