Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Crider Pond

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed intermittent tributary of Rickreall Creek
tributary of Willamette River

3. The amount of water to be stored is 2 acre feet.

4. The use to be made of the impounded water is stock
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 29
(Give sections or townships to be submerged)
Tp. 7S, R. 5W, W.M., in the county of Polk

(a) State whether situated in channel of running stream and give character of material at outlet
in channel of intermittent stream

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions

6. The dam will be located in SW 1/4 of the NE 1/4, Sec. 29
(Smallest legal subdivision)
Tp. 7S, R. 5W, W.M. The maximum height will be 9 feet above stream bed or ground surface on center line of dam. The length on top will be 150 feet; length on bottom 75 feet; width on top 8 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 2.5 feet.
(Feet horizontal to 1 vertical)
