Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Arlin Garber (Name of Applicant)

of RT 2 Box 221 E Dallas (Mailing Address)

State of Oregon 97338, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Garber Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed stream

tributary of Little Luckia mite River

3. The amount of water to be stored is 2.5 acre feet.

4. The use to be made of the impounded water is Stock water
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 17
(Give sections or townships to be submerged)

Tp. 8S, R. 5W, W.M., in the county of Polk

(a) State whether situated in channel of running stream and give character of material at outlet
In channel of intermittent stream

6. The dam will be located in SW 1/4 of the SE 1/4, Sec. 17
(Smallest legal subdivision)

Tp. 8S, R. 5W, W.M. The maximum height will be 9.9 feet above stream bed or ground surface on center line of dam. The length on top will be 235 feet; length on bottom 100 feet; width on top 10 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 2.5 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Compacted clay

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: 4" steel pipe
(All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time)

10. The area submerged by the proposed reservoir, when full, will be 0.5 acres, with a maximum depth of water of 8 feet; and approximate mean depth of water 5 feet.

11. The estimated cost of the proposed work is \$ 1200

12. Construction work will begin on or before As Built
