Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

Tp. 25S., R. 46E., W.M. The maximum height will be 14.0 feet above stream bed or ground surface on center line of dam. The length on top will be 160.0 feet; length on bottom Triangular feet; width on top 12.0 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 4 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: A keyway will be excavated and filled with the best impervious material taken from a borrow area. The dam will be built in six inch layers and compacted with cat and carryall

8. The location of wasteway with dimensions are as follows: Spillway around the west end of the dam. (State whether over or around the dam)

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: None
(All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time)

10. The area submerged by the proposed reservoir, when full, will be 0.67 acres, with a maximum depth of water of 8.2 feet; and approximate mean depth of water 4.5 feet.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Cunningham Reservoir and storage of water from an unnamed tributary of Sucker Creek for stock and wildlife and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the State Engineer to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 3.0 acre feet.

The priority date of this permit is February 18, 1965

Actual construction work shall begin on or beforeAugust 29, 1969..... and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1970..
