

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon 97361, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Kenney Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed ^{Spring} tributary of Jout Creek-Div #3 (Spring)
tributary of Luckiamute River

3. The amount of water to be stored is 3.0 acre feet.

4. The use to be made of the impounded water is Irrigation
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 31

Tp. 9S, R. 5W, W.M., in the county of Polk

6. The dam will be located in NE 1/4 of the SW 1/4, Sec. 31
(Smallest legal subdivision)
Tp. 9S, R. 5W, W.M. The maximum height will be 2.5 feet above stream bed or ground surface on center line of dam. The length on top will be 650 feet; length on bottom 650 feet; width on top 10 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 2.0 feet.
