

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon 97361, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the proposed reservoir is Bauman Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is

unnamed intermittent stream
tributary of Ash Creek - Willamette River

3. The amount of water to be stored is 2.0 acre feet.

4. The use to be made of the impounded water is 0.4 ac.ft. Stockwater 1.6 ac.ft. fish culture
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 21

10. The area submerged by the proposed reservoir, when full, will be 0.51 acres, with a maximum depth of water of 12 feet; and approximate mean depth of water 3.9 feet.
