### Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon 97301, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Stockwater Pond # 4

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed drainage way  
tributary of Luckiamute River

3. The amount of water to be stored is 1.5 acre feet.

4. The use to be made of the impounded water is stock water  
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 21

6. The dam will be located in SW 1/4 SE 1/4 and NW 1/4 SE 1/4, Sec. 21  
(Smallest legal subdivision)  
Tp. 9 S, R. 5 W, W.M. The maximum height will be 8 feet above stream bed or ground surface on center line of dam. The length on top will be 300 feet; length on bottom 40 feet; width on top 8 feet; slope on front or water side 3:1; slope on back 1:1; height of dam above water line when full 3 feet.
