Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Hiebenthal Reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed intermittent Drainageway
tributary of Salt Creek Yamhill River

3. The amount of water to be stored is 4.3 acre feet.

4. The use to be made of the impounded water is 3.3 AF stock water & domestic (see memo) 1.0 AF
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 3
(Give sections or townships to be submerged)
Tp. 7S, R. 5W, W.M., in the county of Polk

(a) State whether situated in channel of running stream and give character of material at outlet
in channel of small unnamed intermittent Drainageway

6. The dam will be located in NW 1/4 NE 1/4, Sec. 3
(Smallest legal subdivision)
Tp. 7S, R. 5W, W.M. The maximum height will be 2.5 feet above stream bed or ground surface on center line of dam. The length on top will be 400 feet; length on bottom 35 feet; width on top 10 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 2.9 feet. trick take is 4 feet than Bottom of spillway

The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: 6" conduit + valve + 12" stand pipe and for truck top (All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time)

10. The area submerged by the proposed reservoir, when full, will be 1.2 acres, with a maximum depth of water of 9.0 feet; and approximate mean depth of water 3.9 feet. See Remarks

domestic use will include irrigation of lawn & garden not to exceed 1/2 acre. The water will be for normal house hold uses such as washing etc.

Stock use will be for approximately 1,000 Pigs per year.

We have a trench well ahead of the dam which we have been using for our domestic and stock water at the present time. This supply usually runs dry in the late summer.
