The length on top will be 320' feet; length on bottom 100' feet; width on top 8' feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 2.5 feet.

Tube & shut off valve.

10. The area submerged by the proposed reservoir, when full, will be 75 acres,  
with a maximum depth of water of 8 feet; and approximate mean depth of water  
4 feet.

11. The estimated cost of the proposed work is \$ 3000<sup>00</sup>

12. Construction work will begin on or before 15 JULY 75

13. Construction work will be completed on or before 30 OCT 75
