

Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, 97063, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the proposed reservoir is unnamed

2. The name of the stream from which the reservoir is to be filled and the appropriation made is an unnamed stream

tributary of Three mile Creek

3. The amount of water to be stored is 1.0 acre feet.

4. The use to be made of the impounded water is Irrigation

5. The location of the proposed reservoir will be in Sec. 10

6. The dam will be located in SW 1/4 SW 1/4, Sec. 10
(Smallest legal subdivision)

Tp. 4S, R. 12E, W.M. The maximum height will be feet above stream bed or ground surface on center line of dam. The length on top will be feet; length on bottom feet; width on top feet; slope on front or water side; slope on back; height of dam above water line when full feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Reservoir is Totally Excavated
