Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Fred Rhodes (Name of Applicant)

State of Oregon, 97378, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is Rhodes reservoir

2. The name of the stream from which the reservoir is to be filled and the appropriation made is unnamed intermittent drainage way on tributary of Goose neck Creek

3. The amount of water to be stored is 2.3 acre feet.

4. The use to be made of the impounded water is Fish Culture & Irrigation (Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 32 Tp. 6S, R. 6W, W.M., in the county of Polk (Give sections or townships to be submerged)

(a) State whether situated in channel of running stream and give character of material at outlet in channel of small drainage way in clay material

(b) If not in channel of running stream, state how it is to be filled. If through a feed canal, give name and dimensions

6. The dam will be located in SE 1/4 SW 1/4, Sec. 32, Tp. 6S, R. 6W, W.M. The maximum height will be 7.8 feet above stream bed or ground surface on center line of dam. The length on top will be 110 feet; length on bottom 20 feet; width on top 10 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 2.5 feet. (Feet horizontal to 1 vertical)

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Constructed of compacted clay material

10. The area submerged by the proposed reservoir, when full, will be 1 acres, with a maximum depth of water of 12 feet; and approximate mean depth of water 2.3 feet.

11. The estimated cost of the proposed work is \$ 2300⁰⁰

12. Construction work will begin on or before 10-73

13. Construction work will be completed on or before 11-74
