Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Robert Stunneley (Robert Stuart Nunneley)

State of Ore, 97523, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

2. The name of the stream from which the reservoir is to be filled and the appropriation made is #2 woodcock Cr. #1 unnamed stream

3. The amount of water to be stored is #2 - 0.3 #1 - 1.0 acre feet.

4. The use to be made of the impounded water is irrigation & Domestic (Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 31 (Give sections or townships to be submerged)

6. The dam will be located in SE 1/4 Sec 31, Sec. 31 (Smallest legal subdivision)

surface on center line of dam. The length on top will be #2 - 20 #1 - 60 feet; length on

bottom #2 - 18 #1 - 55 feet; width on top 8.0 feet; slope on front

or water side 3:1; slope on back 2:1; height of dam above water line (Feet horizontal to 1 vertical)

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Earth & Rock

8. The location of wasteway with dimensions are as follows: #2 - 3.0' x 2.5' x 8' on South side of Dam

1 - 3.0' x 2.5' x 8' in center

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: 14" Culvert in Base of Dam
(All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time)

10. The area submerged by the proposed reservoir, when full, will be #2 - 0.03 #1 - .14 acres,
with a maximum depth of water of #2 - 12 #1 - 10 feet; and approximate mean depth of water #2 - 10 #1 - 7 feet.

11. The estimated cost of the proposed work is \$ 600⁰⁰

12. Construction work will begin on or before Aug. 1, 1977

13. Construction work will be completed on or before Aug 1, 1978

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of reservoir No. 2 and storage of 0.3 a.f. of water from Woodcock Creek and reservoir No. 1 for irrigation and storage of 1.0 a.f. of water from an unnamed stream for irrigation and domestic use to be appropriated under application No. 54588, permit No. 40912.

The right hereunder shall be limited to the storage of 1.3 acre feet.

The priority date of this permit is July 30, 1976

Actual construction work shall begin on or before December 21, 1977 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1978.
