do hereby make application for a permit to construct the 5 rearing ponds reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is Unnamed Stream

tributary to Farmers Creek (Nestucca R.)

2. If not in channel of a stream, state how it is to be filled. a gravity diversion

from the creek into the ponds.

3. The dam will be located in the SW 1/4 of the NE 1/4 of Section 1

4. The maximum height will be 6 feet above stream bed or ground surface at the

centerline. The top width will be 30 feet, slope of upstream face

slope of downstream face, and height of dam above water line when full

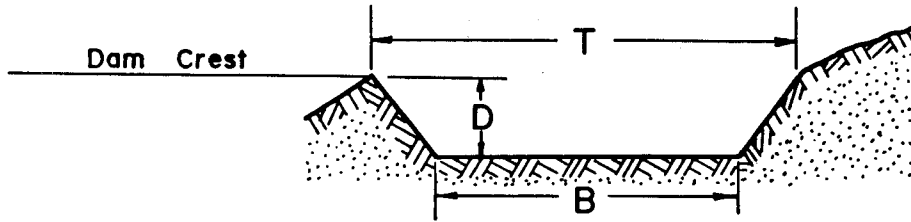


