do hereby make application for a permit to construct the McIntyre reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

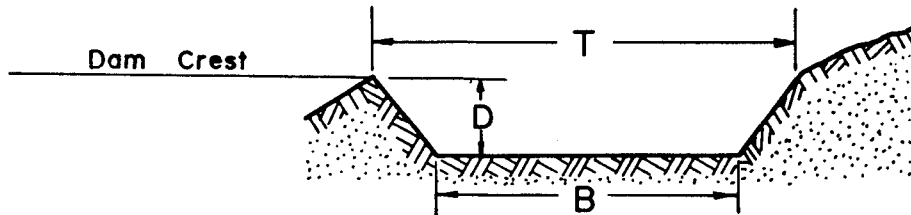

below land surface, no dam. the dimensions are as follows:

surface area - 50 ft x 100 ft


Maximum depth - 10 ft

Average depth - 8 ft

Applicant will flow water into reservoir from Jumpoff Joe Creek through a pipe 125' long. Water will be returned to stream by flowing through 4 ditches, each being 8' wide by 4' deep about 125 to 150 feet to a dry wash which leads into Jumpoff Joe Creek.

DAM a concrete and wood spillway approximately 1 ft wide will be located at the head of each raceway.




This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions. The right herein granted is limited to the construction of McIntyre.. Reservoir and storage of water from Jumpoff Joe Creek to be appropriated under application No. 55637, permit No. 42543, for irrigation and fish culture; being 0.50 a.f. for fish culture and 0.42 a.f. for irrigation.

The right hereunder shall be limited to the storage of 0.92 acre feet.

The priority date of this permit is April 8, 1977

Actual construction work shall begin on or before February 2, 1979 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1979
