do hereby make application for a permit to construct the ..... Pierce #1 and #2 reservoirs  
 and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is ..... Res. #1, Squaw Creek and  
Res. #2, Slicktaw Gulch tributary to ..... Applegate River.

 centerline. The top width will be Res. #1, 10 ft. feet, slope of upstream face ..... 3:1 Res. #1, and #2,  
 slope of downstream face ..... 2:1 Res. #1 & #2, and height of dam above water line when full  
 both  
Res. #1 & #2, 2.5 feet.





*This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions. The right herein granted is limited to the construction of Pierce Reservoirs # 1 and # 2; being 2.5 a.f. in Reservoir # 1 and storage of water from Squaw Creek, and 1.0 a.f. in Reservoir #2 and storage of water from Slicktaw Gulch to be appropriated under application No. 57032, permit No. 43053, for fish culture.*
