
This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Scenic Reservoir and storage of water from Three Fingers Gulch for livestock and wildlife, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 3.48 acre feet.

The priority date of this permit is November 22, 1968

Actual construction work shall begin on or before July 11, 1979 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1980.
