Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

2. The name of the stream from which the reservoir is to be filled and the appropriation made is

3. The amount of water to be stored is 2.7 acre feet.

6. The dam will be located in NW 1/4, Sec. 2
(Smallest legal subdivision)
Tp. 21 S., R. 23 E., W.M. The maximum height will be 12 feet above stream bed or ground surface on center line of dam. The length on top will be 180 feet; length on bottom 120 feet; width on top 10 feet; slope on front or water side 3:1; slope on back 2:1; height of dam above water line when full 3.0 feet.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: earth fill impounding dam.

10. The area submerged by the proposed reservoir, when full, will be .5 acres, with a maximum depth of water of .9 feet; and approximate mean depth of water .3 feet.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Santry Reservoir and storage of water from an unnamed stream for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 2.7 acre feet.

The priority date of this permit is November 14, 1973.

Actual construction work shall begin on or before August 7, 1979 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1980.
